### Technicis continues its growth strategy with a new acquisition in Italy

**Technicis, the leading translation agency on the French market, has acquired Italian translation company Arancho Doc.**

Eighteen months after investment fund NAXICAP Partners took a majority stake in Technicis through a primary LBO, the French agency, led by Benjamin du Fraysseix, continues its growth by acquiring Arancho Doc, one of Italy's most prominent translation agencies. This is Technicis' fourth acquisition since it was established.

Created from the merger between Arancho and LC.Doc in 2011, Bologna-based Arancho Doc is one of Italy's leading linguistic services providers. With locations in Barcelona, Zurich, Prague and Helsinki, Arancho Doc expects a turnover of €12M in 2017. It has 100 full-time employees and a network of 2,000 language professionals offering high-quality translation and interpreting services to 1,200 SMEs and well-known large companies from 45 countries.

Together, Technicis and Arancho Doc expect a consolidated turnover around €45M with 320 employees.
